Bench will go into the Decorative Arts Inventory. Audra talked to Amy Wohlert, chief of staff to president. She looked at will find money to refurbish, \$2600. The partner bench is at University House.

Enrique LaMadrid thought it was WPA made for building, but Audra hasn't been able to find documentation. Benches not in photos from '30, but it doesn't mean that they weren't there.
